RESPONSIBILITY FOR DAMAGES

The Client accepts full responsibility for any damage, loss, or theft of the rented items. The Client agrees to pay 100% of the replacement value of any damaged, lost, or stolen items, including manufacturing, repair, and shipping costs when applicable.

RELEASE OF LIABILITY

The Client acknowledges that once the rental items have been delivered and installed by The Nova Rentals, the Client assumes full responsibility for their safe use and supervision throughout the event.

The Client agrees to maintain a safe environment and ensure that all guests, attendees, vendors, and participants use the rented items safely and appropriately.

The Nova Rentals, including its owners, employees, and representatives, shall not be liable for any personal injury, bodily injury, death, property damage, or other losses resulting from the use, misuse, movement, alteration, or interaction with the rented items after installation has been completed.

The Client agrees to defend, indemnify, and hold harmless The Nova Rentals from any claims, lawsuits, liabilities, damages, losses, expenses, or attorney's fees arising from the use of the rented items during the event.

INSTALLATION & PICKUP

All decorations will be installed and removed exclusively by The Nova Rentals personnel. Changes to the installation or pickup schedule, delays caused by the Client or venue, or requests outside the agreed schedule may result in additional charges.

PHOTOGRAPHIC DOCUMENTATION

The Nova Rentals will photograph the rented items before installation and after pickup to document their condition upon delivery and return. These photographs may be used solely as evidence in the event of damage, loss, theft, or disputes regarding the condition of the rental items.

CANCELLATIONS

The \$50.00 reservation fee is non-refundable. Rescheduling requests are subject to availability.

PAYMENT

The remaining balance must be paid at the time of installation or at the time the rental items are picked up. If payment is not received on the same day, a late fee of \$10.00 per day will be applied until the balance is paid in full.
